Registrasie as Byeboer

Registration as Beekeeper

In terme van paragraaf 5 van Regulasie 1674 soos gepubliseer in Staatskoerant No 6388 gedateer 24 Desember 1998 as addendum tot die Wet op Landbouplae (Wet 36 van 1983), word enige persoon wat 'n heuningby-swerm in SA besit of daarvoor in beheer is, as 'n byeboer beskou en is **wetlik verplig** om, onder andere, by die aangewese instansie namens die Direkoraat: Plantgesondheid te registreer deur die verstrekking van sy/haar naam en adres. 'n Unieke registrasienommer sal vervolgens aan sodanige byeboer toegeken word.

'n Administrasiefooi soos hieronder aangedui, is betaalbaar en sal aan u vrywillige lidmaatskap en lede-voordele van SABIO verleen vir die eerste jaar vanaf registrasie.

Die relevante dokumentasie sal aan u gepos sal word na betaling.

In terms of paragraph 5 of Regulation 1674 as published in Government Gazette No 6388 dated 24 December 1998 as addendum to the Agricultural Pests Act (Act 36 of 1983), anybody who owns or is in control of a colony of honeybees in SA, is regarded as a beekeeper and is **legally required**, inter alia, to register with the nominated institution on behalf of the Directorate Plant Health by submitting his/her name and address. A unique registration number will then be allocated to such beekeeper.

An administration fee as indicated below is payable and will provide you with voluntary membership and member benefits of SABIO for the first year after registration.
